Gender Diversity Champion in Tasmanian Resources

The Women in Resources National Awards is a partnership between the Minerals Council of Australia and its Northern Territory and Victorian branches, the Chamber of Minerals and Energy Western Australia, the Queensland Resources Council, the New South Wales Minerals Council, the South Australian Chamber of Mines and Energy, and the Tasmanian Minerals and Energy Council, also supported by various state WIMnet branches. The awards profile women in the Australian resources sector, providing ambassadors and role models as an aid to the attraction and retention of women in the resources sector. The Australian resources sector has a goal of at least 20 per cent women in non-traditional roles by 2020.

The Tasmanian awards are jointly run by the Tasmanian Minerals and Energy Council and the Tasmanian Branch of WIMnet, with the Tasmanian State winners progressing through as the Tasmanian State representatives in the Women in Resources National awards.

By submitting your entry in the Tasmanian State awards you are also consenting to the submission of your entry to the National awards if you are the State winner.
